Method: In-person ballot voting only

Important voting rules:

- Only registered owners in the Whakapoungakau Lands Trust are eligible to vote.
- Each owner is entitled to submit one (1) voting form. Duplicate submissions will be invalid.
- You may vote for up to three (3) candidates, as there are three trustee spaces available.
- Completed voting forms must be folded and deposited in the ballot box at the registration table.
- Late votes will not be accepted.
